## HomeGoods "Customer Satisfaction" Sweepstakes OFFICIAL RULES

## NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT IMPROVE THE CHANCES OF WINNING.

The "Customer Satisfaction" Sweepstakes (the "Sweepstakes") is intended for legal residents of the United States and shall only be construed and evaluated according to applicable U.S. law and state law.
